## Wall Report

Our perimeter wall is almost finished! As you can see, the main construc-

tion has been completed and we are finalizing the finishing touches that need to be done. A final walkthrough has been scheduled with InStone to review the work and correct any aesthetic problems. A clean-up of the left-over bricks, construction materials, and leftover dirt/mortar are also to be expected. The majority of the entryway holly bushes could not be maintained and allow accessible construction at the same time. The board is working to remove these bushes

Next Quarterly Meeting

ATTENTION!!! The next quarterly meeting will be October 18th at 7:00pm at the Vist<mark>a Ridge United Methodist</mark> Church across the street. This meeting is to educate homeowners on the recent community projects and hear reports from the various committees. We would like to put two issues to vote at this meeting: the addition of a playground at the top of the "rock hill" in the 45X greenbelt and whether or not to approve the project to install permanent lighting to our two entryways. Both of these issues will be outlined and described in detail, in order for the homeowners to have all available information before offering a vote. All homeowners are welcome to attend to further educate themselves about the community and homeowners in good standing will be allowed to vote--a quorum will be required, so please make an effort to attend this meeting if you have questions or opinions about these issues!! If you are unable to attend the meeting, please feel free to contact the board for more information about these issues and send in your proxy to have your opinion counted!

#### **Reserve Study Report**

For those that may have missed the July Quarterly meeting, we reviewed the results of the Reserve Study. This was a study completed on all the assets of Coppell Greens and a recommendation on the amount of income needed to sustain our community. HOA's are not allowed to be run



at a "for-profit" rate and we were advised that our dues "more than, if not excessively funded our reserve fund needs". Given this information, the board decided to lower the \$60.00 monthly dues to \$55.00 per month beginning in October. After reviewing the budget and actual expenditures over the last four years, the board is looking to lower the dues another \$5.00 in January. Even after lowering the amount twice, the HOA is still saving for maintenance repairs to any of our capital assets, our general operating costs, AND funding the reserves at an amount slightly over what the reserve study recommended. The reserve study is available for anyone's review on our website. The board plans to do a presentation of the reserve study and our analysis of the last four years expenditures/income at the next annual meeting in March 2008.

### Solicitors

If they are rusted or fading, please sand and paint them in order to improve their appearances and stay within HOA guidelines.
