



### Annual HOA Meeting

### Pond Dredging

Dredging of the pond began back before Thanksgiving and has been progressing slowly due to the cold weather and other factors. About 900 cubic yards of water and muck has been pumped into the large bags surrounding the pond and all of the cattails have been removed. After all of the water bleeds out of the bags, the remaining 450 cubic yards will be hauled off, hopefully by May. After we are done, we will install a fountain in the pond. The Board recognizes that it is unsightly and is an inconvenience to have the sidewalk by the pond blocked. However, we want to remove as much material as possible now so that we don't have to do it again for a decade or more in the future. Your patience is greatly appreciated, especially those living by the pond.



### Mullrany Timber Walls

At the end of March, the HOA will be having the failing timber walls behind 867 & 871 Mullrany replaced with milsap stone walls. The plans for Coppell Greens state that it is the HOA's responsibility to maintain all walls within Coppell Greens. With the building of the SRINI development to our south, it has become imperative that we get the work done now before access to the area is restricted.

If you have any questions, please send an e-mail to us at: acc@coppellgreens.com. If work is not approved and does not conform to the by-laws and community standards, you will be forced to remove it. That includes changing the style, height, or location of your fence.

### Dead Bushes & Trees

In February of last year, the Big Freeze severely damaged or killed many trees and bushes throughout Coppell Greens. If you have not pruned or removed them, please do so soon. If they are not corrected, SpectrumAM will start issuing notices. In order to maintain the value of our homes, it is important to keep them looking nice.

If you have a metal fence in your backyard, it is your responsibility to maintain it. There is a misconception by some that, because it is adjacent to a greenbelt, that it is therefore the HOA's responsibility. After 20 years, many have started to rust. Scraping, sanding and then spraying the fence with Rustoleum paint can help save it.

### **Political Signs**

Our by-laws address political signs and state that you are allowed to place them in your yard with certain restrictions. However, you are not



allowed to place them on HOA property or easements which includes at the entrance islands, flower beds, in front of the brick panel walls along Denton Tap, or in the greenbelts.
